Questions and answers

Q1. I am writing to you today because we intend to bid on the Port work. However, our Bid Bond provider requires that we identify the proper address where the work will be performed. Can you share that official address with me, please?

Q2. Also, can you confirm how many years the Port contract is required to be and thus how long the bill rates in our bid must remain unchanged?

A. Section 28 in bid package.

28. LENGTH OF CONTRACT

28.1 The contract time for the scope of services will be for a period of one (1) year with an option which may be exercised by the City to renew annually at the same rates and under the same conditions for up to two (2) additional 1-year terms upon provision of written notice to the Contractor at least 30 days prior to the expiration of the contract.

Q3. Pursuant to Florida Statute 119.07, public records law, we would like to see the winning bid for the current contract. Specifically we would like to see the name of the current contractor, current hourly billing rate, and current annual total contract amount. We would also like to see the current security officer hourly pay rate, if it is available.

- A. The current company is Inner Parish Security Corporation (IPSC). The contract was awarded in 2019 from Bid #20-002 for \$206,024.00.
