SUBJECT: Nominations – Eastside Redevelopment Board

SUMMARY:

The Eastside Redevelopment Board was established pursuant to the requirements of Florida Statute 163.2517 (2)(a)(b) regarding a neighborhood participation process that provides for the ongoing involvement of stakeholder groups in urban infill and redevelopment areas.

The Eastside Redevelopment Board shall consist of five (5) members: Two (2) homeowners and one (1) owner of a business located within the Eastside Neighborhood TIF District area appointed by the City Council; a representative of the Eastside Neighborhood Improvement Association designated by the association; and one (1) member of City Council. No member shall be a paid employee of the City.

The term of Board Members Martha Erinkatola and Jeannie Rhoden, homeowners in the Eastside Neighborhood TIF District; and Sonny Granger, owner of a business located with the Eastside Neighborhood TIF District, will expire March 30, 2016. Jeannie Rhoden has indicated that she would like to be considered for reappointment.
